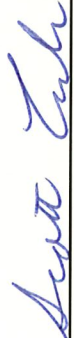
Other Matters

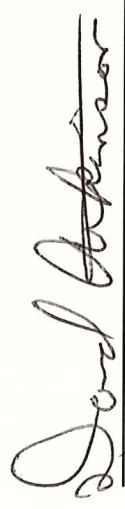
There was discussion on Drainage Projects.
