### **Mount Ayr Town Board**

Howard Marshall & Jerry Durflinger were present to discuss recent flooding concerns.

Discussion was held regarding Stucker Tile, roadside drainage along CR 300 and the age/working condition of the tile. There was inquiry from the Town Board as to the age of the tile and if it were still in working condition, along with if it should be replaced. The Drainage Board informed the Town Board that if they feel it necessary to replace the tile, the Town may prepare a petition for this work.

Discussion was held regarding a tile hole at CR300 & SR 55, which Surveyor Watkins had previously hired a contractor to repair.

Glen 'Butch' Cain requested that Surveyor Watkins reach out to the Highway Department to clear the corner of SR 55 E to where it crosses the road.

Regarding the watersheds that affect Mount Ayr – Haynes Turner Combination & Stucker Combination and Stucker Mount Ayr – Secretary Jamie Rowe will email a copy of parcels within each for the Town Board to have on record.

### **Lawler Culvert**

Dave Kmiec was present to discuss a culvert that has been on his property, awaiting placement, for five years.

Scott Carlson made a motion to have Surveyor contact JD Excavating to put it in and this will be paid for by the Lawler watershed. Second by Abbey Rossiter. Motion passed 3-0.

#### **Best Ditch**

Surveyor Watkins updated the Board on his communications with Jason Durr of CBBE, regarding the next steps to take in correcting the issue presented by Zack DeYoung w/ LaSalle Fish & Wild Life at the February 6, 2023 meeting.

The Board is in agreement that they would like for Mr. Durr to continue to look into the permitting needed to accomplish this project. Glen 'Butch' Cain suggested Surveyor Watkins take pictures to show the drainage issues.

### **2023 Drain Assessments**

Secretary Jamie Rowe presented the Board with an updated Certified Drains for Assessment list. Scott Carlson made a motion to accept and approve the updated Certified Drains for Assessment list. Second by Abbey Rossitter. Motion passed 3-0.

### **Other Matters**

Glen 'Butch' Cain informed the Board that he and Surveyor Watkins attended the Town of Kentland's meeting on March 9, 2023, regarding drainage issues they have experienced.

Jamie Rowe brought up the scheduling of a Newton-Jasper Joint Drainage Board Meeting. The Board decided to postpone a joint meeting until August, as there would be nothing for the agenda at this time.

Scott Carlson inquired about Certified Ditch Miles and Cornerstone Perpetuation. Surveyor Watkins stated that Schneider Geomatics is contracted for this work, and will stop once they reach the \$5,000.00 that was budgeted for this work.

Abbey Rossiter made a motion to adjourn. Second by Scott Carlson. Motion passed 3-0.
